1. Call to order – Rod Zeigler

The meeting was called to order at 1:05 PM.

2. Approval of Meeting Minutes

Jim Timm made a motion to approve the SECC minutes as presented. Al Krause seconded the motion; the motion passed by consensus.

3. SECC Charter Change – Rod Zeigler

Rod Zeigler presented the change to the SECC charter to the Nebraska Public Safety Communications Committee, which was approved by the NPSCC at their meeting on September 3, 2015.

4. Website update - Janell Walther

Rod Zeigler proposed a change to the front page of the website via email in August. Currently, the 2007 EAS Plan, not approved by the FCC, is posted on the website. The recently revised EAS plan has not been approved by the NPSCC or FCC, and cannot be posted publically yet. Rod Zeigler will send Janell Walther an updated list of LP-1 stations to post on the Monitoring web page. Al Krause made a motion to approve the web content as presented (see Attachment A). The motion was seconded by Jim Timm; the motion passed by consensus.

5. EAS Webinars - Rod Zeigler

Rod watched two EAS webinars last month, one dealing with multi-lingual EAS, and one dealing with enhanced EAS. Multi-lingual EAS is being done in Minnesota, beginning with the twin cities and expanding statewide by the end of Fall 2015. Languages include Spanish, Somali, and Hmong. Language selection is at the station discretion; however, items are in the Latin alphabet and are 90 characters each.

The second webinar reviewed Enhanced 911 service. There is some consideration for dispatchers sending EAS alerts. The webinar discussed alerts for blind, deaf, and hard of hearing communities. Wireless Emergency Alerts (WEA) is relevant to reverse 911 and alerting service.

6. Old Business

- Paul Johnson reported that Douglas County is now an approved COG.
- Jim Skinner reported that the text to speech and crawl requirements deadline is in November 2015.
- The Attorney General encouraged that the Amber Committee to pay attention to IPAWS.
- An update on the Standard Operating Procedures committee status is planned for the next meeting.

The EAS system in Nebraska continues to operate under the drafted and distributed (but not officially approved by the FCC) 2007 Emergency Alert System Plan with some necessary changes which are listed below.

An updated plan was sent to the FCC for official approval in early 2015. All Nebraska EAS stakeholders will be notified if and when it is approved. Plan distribution and plan start date will follow at some time afterward.

Any changes in the FCC EAS Rules and Regulations that have occurred since the distribution of the 2007 Plan are automatically included in all current and future Nebraska State EAS Plans. These changes are to be implemented by all EAS stakeholders as stated in the FCC Rules and Regulations.
